IN ADDITION, THE BALANCE OF NEARLY \$52,207,000 IN OUTSTANDING INTEREST-FREE LOANS TO 4,700-PLUS MILITARY CHILDREN EQUATES TO OVER \$2,600,000 IN DIRECT SAVINGS TO STUDENTS (BASED ON AN AVERAGE INTEREST RATE OF 5%).
