# Your Guide to Absentee Voting



Every member of the military deserves to have their vote counted — no matter where they are in the world. That's why MOAA has created an absentee voting guide to make everything clear for you — from deadlines to submission guidelines to following up on your ballot's status.



### **STEP 1: REQUEST YOUR BALLOT**

To complete this step, download and fill out a Federal Post Card Application (FPCA)<sup>1</sup>.

After you've completed your FPCA, return it to your local election office. Find the address on your <a href="mailto:state">state</a>
<a href="mailto:voting information page">voting information page</a><sup>2</sup>.



Some states allow email and fax submissions as well. You can access <u>online assistance</u><sup>3</sup> if needed to get more information on when and where to send your completed form.

Check your state voting information page for additional submission information and deadlines.

## **STEP 2: LEARN YOUR DATE TO SUBMIT**

You can submit an absentee ballot from anywhere in the world; however, your location will determine your official deadline to submit. See below for general recommended dates to return your ballot based on your current location.

Since guidelines vary by voting jurisdiction, be sure to visit <a href="www.fvap.gov/military-voter">www.fvap.gov/military-voter</a> for your official deadline to submit your ballot.

### **STEP 3: COMPLETE AND SEND IN YOUR BALLOT**

After submitting your FPCA, you will receive your ballot no later than 45 days prior to the federal election.

Simply complete it and return by the appropriate deadline using the instructions provided with the ballot.





#### **INFORMATION FOR MILITARY SPOUSES**

Spouses and eligible family members of servicemembers wishing to use an absentee ballot can follow the same steps outlined above to cast their vote.



#### **CHECK YOUR BALLOT'S STATUS**

Want to know the status of your ballot after you've sent it in? Visit your <u>state voting information page</u> to make sure your vote has been received.



#### **DIDN'T GET YOUR BALLOT?**

While you should receive your ballot by early October, if it hasn't arrived by October 8, that's okay. You can obtain a Federal Write-in Absentee Ballot (FWAB) <a href="here">here</a> or <a href="here">use the online assistant</a>. Simply fill it out and send it in just like a regular absentee ballot.
