State of Councils and Chapters

- Current numbers:
 - 32 councils
 - 322 geographic chapters (down 23 from last report)
 - 7 virtual chapters
 - 10 satellite chapters
 - 60 chapters are classified "ailing"
- Why are we losing chapters?
 - Lack of leadership
 - Stagnant or declining membership
 - Aging demographic



Health V. Effectiveness

A healthy chapter is an organization that is able to sustain itself over time.

An effective chapter is one that positively impacts MOAA's mission.



Effective Councils

- Represent the consensus of member chapters
- Mentor chapter leaders
- Provide a forum for exchange of ideas
- Lead and coordinate state legislative matters in interest of the military and veteran community
- Support MOAA's legislative and other priorities
- Visit chapters, participate in virtual meetings
- Help monitor and maintain healthy affiliate system of chapters



Effective Chapters

- Have a clearly stated chapter purpose/mission statement
- Focus on leadership pipeline and best practices
- Impact legislation through advocacy and engagement
- Engage in impactful community service
- Promote membership growth through recruitment and retention



Understanding At-Risk Affiliates

- What are the challenges?
- Is the council involved?
- What resources can we share?
- Can we connect the chapter to a mentor?
- Can we help support revitalization efforts?
- Is closure imminent? If so, what are the next steps?
- How can we ensure members stay connected?



Way Forward

- Council/chapter input on state chapter health is critical
- Concurrently contacting "dormant" chapters for status
- Bring resources to bear for ailing chapters
 - Email blasts, postcard mailing, membership drives, speakers
 - Leveraging and facilitating privacy policy change/new prospects
 - Council and Chapter Visit Program
- ACC is hosting a mentoring roundtable in September

Skip's Tips

- Get to know any civilian county VSOs in your catchment area. Share chapter info: copies of newsletter or other membership materials, upcoming events, etc. Ensure the VSO knows of the MOAA Foundation crisis relief program, interest-free education grants and loans, MOAA transition webinars, etc.
- If there are county or area-wide events, offer to sponsor a portion, like providing water or dessert. See if the chapter can set up a table.
- Develop relationships with Commanders, XO's, and Senior NCOS and share these resources. In addition to supporting JROTC and ROTC award programs, make sure they're also aware.
- Do the same for Family Readiness Groups, especially if they have an off-post/out of the Reserve Center/Armory. Offer to sponsor some part of the event.

Skip's Tips

- Host an information table at job fairs, especially veterans job fairs.
- Sponsor a table at a local farmer's market.
- When advocating with elected officials mention the MOAA Foundation grant programs that demonstrate that while "MOAA is an organization of officers, it is not an organization just FOR officers."
- Councils can establish a recruiting budget line from which chapters can get at least partial reimbursement for incurred expenses. In NYS, they provide up to \$125.
- Council leaders can offer to accompany chapters as they do the above things.

Leadership Succession


- Consider most critical needs first
