General Counsel Issues



Liability Insurance

- Legal exposure/risks
 - Community facing events/interaction with the public
 - Rented space or "special events"
 - May be required to receive MOAA grant funding
- Advantage of establishing legal entity
- Insurance general liability, property, rental, Hired/Non-Owned Auto
 - AMBA (through Philadelphia Insurance Companies)
 - Lockton (through Hanover Insurance)
 - Local/call for quotes




Chapter Incorporation

	501(c)(3)	501(c)(4)	501(c)(19)
Purpose	Charitable, Scientific, Educational, Religious, Literary, etc.	Civic and Social Welfare Organizations (PACs)	Veterans &Their Families (List)
Membership Requirements	No	No	 75% past or present service members 97.5% past or present service members, cadets, or spouses, widows/ers, ancestors, or lineal descendants thereof
Lobbying	No: limited exception for "insubstantial" activity (% of \$ spent)	Yes: generally unrestricted unless receives federal funding and cannot be organization's primary activity (general welfare)	Yes: non-partisan and only as relates to its purpose
Offer Insurance to Membership	No	No	Yes
Donations Tax Deductible	Yes, if used for purpose and only that amount > FMV of goods and services received	No	*Yes, if used for purpose and only that amount > FMV of goods and services received
Miscellaneous			*Congressionally Chartered "Veterans Service Organization"



Copyright Infringement

- Copyright Protects original works of authorship
 - Literary, dramatic, musical, artistic expressions, poetry, novels, movies, songs, computer software, architecture articles you want to reprint
 - Owned by creator of the work
 - Lasts for 70 years after death of creator
- Infringement
 - Unauthorized use of the work
 - Reproducing, publishing, performing, filming, broadcasting making an adaptation
 - Authorized use written permission or a license
 - Exceptions fair use, educational use, parody/satire, news reporting, fair dealing, preservation purposes
 - Legal tests, case-by-case application of facts: commercial interest, amount copied, etc.
 - Not a bar to being sued, a defense you must prove in court
 - Webmasters put it in a contract and require insurance
- Enforcement
 - Production companies and groups of artists use hired web crawlers and AI search engines
 - Cost to consult an attorney is more than paying the settlement demand
- DoD and Service Marks and Seals
 - Trademark protected
 - Strict enforcement of unauthorized use per DoDI 5535.12, DoD Branding and Trademark Licensing Program
 - You must obtain permission from each Component to use a mark or seal it's never given
 - Precedent and preferential treatment
 - Risk of losing protections
 - See my Guidance Memo, dated May 19, 2025, to Council & Chapter Leadership





MOAA Data Privacy Policy

- In absence of Federal law, states are filling the void
- International (EU) requirements (GDPR)
- Retained outside counsel with data and privacy expertise
 - Delivery
 - Refinement
 - Implementation Phase I
 - Publication/Issuance
 - Implementation Phase II

Crafting Messages to Different Cohorts: July 14th

- Honor the decision of those who have opted out via an affirmative action.
 - Inform of Policy & offer *resubscribe*
- Those who have only been opted out by default (not by any affirmative action) will default to opted in
 - Inform of Policy & offer unsubscribe



General Counsel Support of Councils & Chapters

- Separate, independent affiliates by design
 - MOAA Bylaws, Article II Affiliates, Section 1:
 Affiliation "does not authorize either organization to participate in the organizational or managerial concerns of the other"
 - Liability and administration would be untenable
 - C/C need freedom of maneuver within their AORs
- General Counsel Employment Agreement Restriction
- Virginia Corporate Counsel Bar License Restriction
