e're very pleased to present this combined annual report of our two MOAA charities: the MOAA Foundation and the MOAA Scholarship Fund. These two award-winning MOAA subsidiaries continue to have a significant, positive impact on our nation's military and veteran families every year, and 2018 was certainly no exception.

Before you read the reports, however, I'd like to ask you to take just a few moments to consider the future of these two wonderful organizations. As you know, last year, the MOAA Scholarship Fund celebrated its 70th anniversary. Since 1948, the MOAA Scholarship Fund has provided more than \$150 million in educational assistance to more than 15,000 military family children. The MOAA Foundation, on the other hand, is now entering just its fifth operational year. The MOAA programs it funds help more than 100,000 military and veteran families annually. Despite their obvious differences, our two MOAA charities share a common mission and a common reality: They both serve uniformed and veteran families, and they both rely heavily on individual contributions from MOAA members to sustain them.

Individual donations and bequests are the two most vital sources of sustaining revenue for most nonprofit organizations, and a robust, annual individual-giving program forms the basis for a successful planned giving program (bequests). But only about 8 percent of our 350,000 MOAA members ever have given to either charity. Moreover, a recent MOAA member demographic survey revealed **43 percent** of MOAA members have a net worth over \$1 million, and the **average MOAA member age is 68.** Given these facts, let me illustrate the potential giving power our members could have going forward.

As many of you have heard me say, if just one in 10 MOAA members — about 35,000 members — gave just \$50 once a year to each MOAA charity, both charities would receive \$1.75 million annually. That's more than enough to sustain their operation in perpetuity. If we take it a step further, and just 1 percent of those same 35,000 MOAA members who give annually — that's just 350 MOAA members — made a \$50,000 bequest to each charity, each charity would ultimately receive \$17.5 million from those 350 MOAA members.

Couple Honor the Past and Future

n his first day as a young Army officer at Fort Bliss in El Paso, Texas, Joseph A. Simonelli Jr. encountered a teacher helping her friend move a couch, and he offered his assistance.

Thus began 32 years of helping together for teacher Bettye Marie and Colonel Joe, as the retired officer is now known.

Since those early days at Fort Bliss, the Simonellis have developed a deep commitment to assisting veterans, military families, and organizations like MOAA. Retired from 30 years in their respective military and teaching careers, they have never stopped serving.

Their dedication includes establishing a MOAA Designated Scholarship to honor Bettye Marie's late parents and being silver-level Heritage Society donors to the MOAA Foundation, which provides programs and services to servicemembers and veterans and their families.

These donations, the Simonellis say, allow them to honor the past while providing for the future. The Violet and Paul Dickerson Designated Scholarship, for example, helps students from military families pursue degrees in educational fields. The Simonellis' \$25,000 already has provided three scholarships to future teachers, a continuation of a family legacy of education. Bettye Marie's mother, Violet Dickerson, devoted her life to teaching,

and her father, Paul Dickerson, became a teacher after his retirement as a lieutenant colonel from the Army.

The scholarship also lets the couple show their gratitude. "We're honoring the legacy of Bettye Marie's parents and what they meant to us," Joe says.

The scholarship is fitting in another way, too. Bettye Marie's mother was the one who introduced Joe to MOAA. During a visit, a discussion unfolded about active duty military being involved on a MOAA committee. "My mother-in-law leaned over to me and said, 'Joe, you can do this,' "Simonelli says.

That led to Joe serving two years on MOAA's Active Duty, Guard and Reserve Advisory Committee to the board of directors, followed by six years as MOAA's first active duty, active component board member.

Military life for the Simonellis

included 17 moves, with Joe in Army leadership positions, from garrison commander (mayor) of Fort Bliss and director of house affairs for the secretary of defense to chief of staff of Arlington National Cemetery. He is also a veteran of the Gulf and Iraq wars. Bettye Marie chuckles when she says she taught in whatever grade level needed each time they relocated. She also served as a liaison between the military and schools.

The couple now live in northern Virginia, and Joe works as vice president for client engagement, community relations, and government affairs for Warrior Centric Health Care, LLC.

And they continue lending a hand together, as they did 32 years ago in El Paso. "We've always wanted to be available to individuals," Joe says. "We've all been there." [[[]]

am pleased to report 2018 was a banner year for the MOAA Scholarship Fund and Educational Assistance programs. The MOAA Scholarship Fund received \$1 million in donations from individuals, chapters and councils, foundations, and corporations. The fund also received nearly \$12 million in bequests. A Legacy of Dedication

hen Capt. Walter L. Goldenrath retired from the Navy in 1975, the surgeon general of the Navy presented him with the Legion of Merit and Meritorious Service Award, and the Navy recognized him and his wife, Sylvia, for their contributions during his career. Among the projects Goldenrath contributed to during his time in the military. and in a post-military career at NASA, were research and development of aircraft ejection seat systems and flight suits and associated equipment, and the health impacts of low-gravity environments.

In addition to the legacy of a lifelong commitment to aeronautical health and safety, he and his wife will be remembered for years to come by generations of military children — 47 in the 2018-19 academic year, four of whom are profiled below — who receive grants funded by the Goldenraths' generosity.

Goldenrath was a naval aviator in World War II, flying the Consolidated PBY Catalina on search-and-rescue and reconnaissance missions in the Pacific Theater. After the war, he continued to serve as a naval reservist while attending medical school at the University of California at Berkeley, and when he was recalled to duty during the Korean War, he was assigned to the Naval Medical Institute.

Following his wartime service, he returned to Berkeley, where



studying

he taught at the medical school, pharmacy school, and dental school. He returned to active duty in 1955 and helped develop a high-altitude suit that was later worn by Project Mercury astronauts Alan Shepard and John Glenn. After his military retirement, he worked with NASA's Technology Transfer Office, seeking civilian applications of biomedical technology.

Goldenrath retired for good in 1997, and he and Sylvia lived in California until her death in 2003. In 2004, he was inducted into the Hall of Fame of the Smithsonian National Air and Space Museum. He died in October 2010 at age 92.

SCIENCE AND INDUSTRY
